#### 6. Old Business:

Jason Webb made a motion to take the Approval of Part VIII Financial Policy off the table for review, seconded by Ron Beckman and passed.

Brinkmann announced that Chief Larson added Part G. Waiver of Liability. The Financial Policy, Part VIII, Surplus Property was reviewed by the board. Ron Beckman made a motion to approve the Financial Policy, Part VIII, Surplus Property. Jason Webb seconded the motion. The motion passed.

#### 7. New Business

#### A. Update on the 2020 Board of Directors Election:

Brinkmann updated the board on the Cancellation of the Regular Election. As of the close of business on March 3, 2020, there were not more candidates than offfices to be filled.

#### B. Update on the Administrative Assistant Position:

# D. Designated Signers on Loan Documentation for the purchase of 165 N. Pagosa Blvd:

Ron Beckman made a motion to designate Randy Larson, Fire Chief and John Thompson, Board Chairman to sign all purchasing and loan documents for Pagosa Fire Protection District pertaining to the acquisition of 165 N. Pagosa Blvd., seconded by Jason Webb and passed.

#### E. ISO Rating:

Deputy Chief Macht opened discussion in reference to the current ISO documents included in the board packet. He stated the ISO rating was reduced from a 4/10 rating to a 3/10 rating. The board discussed the process of lowering an ISO rating. Webb inquired on how the information was given to the public. Brinkmann explained the process of Insurance Agency inquirying about ISO ratings.
