# 4. Approval of the June 14, 2022 Minutes

Chief Larson requested direction in regards to the antique truck. Discussion took place and Chief Larson will return to the Board with approximate budget costs to establish the truck road worthy at a later date.

# C. Employees Pay and Archuleta County Living Wage Document

Director Hooper moved to direct Chief Larson to consider salaries as a high priority with no specific times or numbers within the best of his abilities when considering staffing budgets. Martin seconded the motion and passed with Hooper and Martin voting "Aye" and Lattin "Nay".

D. Discussion and Direction of a New Fire Station on the East Side of the County

Director Hooper moved to direct Chief Larson to approach the Town, County Officials, and Hospital District to explore forming a Joint Powers Authority (JPA) to build a fire station and report back to the Board. Martin seconded the motion. Discussion took place with suggestions of taking initial steps to form a JPA. Director Hooper amended his motion to direct Chief Larson to meet with entities with mutual interest to establish a JPA to look into emergency services infrastructure. Martin seconded the motion and it passed unanimously.
