



#### Fire Code Plan Review

### **New Construction**

#### Defined as:

- Any addition to land or improvements
- Physical alteration of any improvement, or a portion thereof, to a "like new" condition, or to extend its economic life, or to change the way in which the improvement to, or portion thereof, is used.
- Any substantial physical alteration of land which constitutes a major rehabilitation of the land or changes the manner in which it is used.

The fire code plan review includes plan review, review of corrected drawings and required inspections. If the drawings must be reviewed more than 2 times, an additional fee of 50% of the original fee is incurred.

### **Change Orders**

Fee is per hour required to review the change order(s) with a minimum of 1 hour. \$50.00/hour

#### **Phased Projects**

Phased projects are generally seen in new construction where a large building is broken into smaller pieces to assist design and construction needs. Breaking down a building into smaller logical construction/permit phases allows construction while still finalizing the design requirements. Additional inspections are \$100.00 per inspection.





### Remodels

Remodeling work is not subject to fire code plan review unless there is a change in square footage, walls, means of egress, use, occupancy type, or life safety systems installed in the structure.

Remodel fees are 50% of new building construction fees with a minimum fee of \$150.00.

The fire code plan review for remodels includes plan review, one review of corrected drawings and required inspections. If the drawings must be reviewed more than 2 times, an additional fee of 50% of the original fee is incurred.

### **Technical Assistance**

If outside technical assistance per the adopted fire codes for Pagosa Fire Protection District is required, the associated fee will be the actual cost of the technical assistance.

### **Water Tanks for Fire Protection**

This is a plan review and acceptance test fee to install water tanks/cisterns that are required to hold water supply storage for fire protection. This excludes tanks for single family suppression systems. \$200.00

### Additional/ Re-Inspection 2<sup>nd</sup> or more

The fee for additional inspections and Re-Inspections are \$100.00 per inspection.

### **After Hours Inspection**

The fee for afterhours inspections is \$100.00 per hour, per inspector. (2-hour minimum)

### Occupancy Load Calculation/Signage

A fee of \$35.00 will be charged for occupancy load calculation and signage.





### Fire Suppression System Plan Review

New or remodeled systems must be permitted through the fire department prior to installation.

# <u>Small Project Modification/Addition to Existing NFPA 13/13R/13D/Combination</u> <u>System</u>

- Small project Level I (6 or less sprinkler heads added, relocated, or removed). \$50.00
- Small project Level II (6 to 20 sprinkler heads added, relocated, or removed). \$100.00 plus \$2.00 per sprinkler head.

Maintenance is work that is required to maintain the system or replacement in which the parts are the same type and model, no plan review or fee is required.

### Fire Protection Underground

Plan review and acceptance for installing, extending, or altering underground fire service mains related to fire suppression systems. \$200.00

### **NFPA 14 Standpipes**

Plan review and inspection for standpipe is separate from the automatic fire sprinkler system. \$200.00 for each standpipe riser in the facility.

### NFPA 20 Fire Pumps for NFPA 13/13R Systems





Plan reviews for fire pumps are separate from the review of the automatic fire sprinkler system. Single family residences are excluded. \$400.00

### **Commercial Cooking Fire Suppression System**

New systems or remodeled systems must be reviewed, permitted, and inspected by Pagosa Fire Protection District. \$250.00 per system.

### Other Fire Suppression Systems (i.e., Clean Agent)

New or remodeled systems must be reviewed, permitted, and inspected by Pagosa Fire Protection District. \$250.00 per system.

### **NFPA 72 Fire Alarms**

Definition of device includes the fire alarm control panel, remote annunciator, notification appliances, detection appliances, and releasing modules.

### **New Systems or Major Remodels**

New or remodeled systems must be permitted through the fire department prior to installation. The fee for the plan review and inspection of each system in a facility is \$200.00 per system plus \$2.00 per device. If the drawings must be reviewed more than 2 times, an additional fee of 50% of the original fee is incurred.

### **Small Fire Alarm Project**

Small projects to an NFPA 72 System are defined as a modification to an existing system with 5 or less devices. This includes the plan review and required inspections. \$50.00 plus \$2.00 per device relocated, added, or deleted.

### <u>Dedicated/Releasing Function Fire Alarm System</u>

A protected premises fire alarm system installed specifically to perform emergency control function(s) where a building fire alarm system is not required. Includes review and inspection. \$50.00 plus \$2.00 per device.

Pagosa does not charge fees for any fire response within the boundaries of Pagosa Fire Protection District.

### **Motor Vehicle Incidents**

Response to motor vehicle incidents will be billed to all non-residents of Pagosa Fire Protection District. Rates for motor vehicle incident response are based off of Exhibit A in the Fire Recovery USA Services Agreement.

### **Out of District Fire Response**

Response to emergencies outside of Pagosa Fire Protection District boundary will be billed at the current Colorado Resource Rate Form (CRRF) for Apparatus. Personnel will be billed per rates used in the Colorado Fire Billing System. This does not include mutual aid within neighboring Fire Districts or Federal Lands.

### **False and Nuisance Alarms**

False/Nuisance Alarm quantities are based on the calendar year (January 1<sup>st</sup>-December 31<sup>st</sup>).

### **Open Records Request**

Open records request will furnish copies requested at the rate of \$0.25 per page. Where the location or existence of specific documents must be researched and the documents must be retrieved, sorted, or reviewed for the applicability to the request and the process requires more than one hour of staff time, the research and retrieval fee shall be \$40.00 per hour after the first hour.
