# A. Consideration – Resolution 2023-01 Adopting the Archuleta County Multi-Hazard Mitigation Plan

Chief Larson and Emergency Operations Commander, Ryan Foster, advised the standard procedure regarding the Archuleta County Multi-Hazard Mitigation Plan. The process occurs every five (5) years. Resolution 2023-01 was approved with a motion by Ryan Foster, seconded by Martin and passed unanimously.

### **B.** Fire Station Act Discussion

Chief Larson advised HR1814 has been introduced to the 118<sup>th</sup> Congress. Chief Larson suggested a letter from the Board supporting the Bill to be sent to State Representatives. Director Martin inquired if the District had access to a grant writer, upon which Director Beckman advised he would be willing to teach a class. Ryan Foster moved to approve a letter to be sent to state representatives regarding HR1814. The motion was seconded by James Martin and passed unanimously.

# C. Fire Chief Upcoming Vacancy

Director Beckman provided information from research he performed. Discussion took place and a sub-committee was formed consisting of Beckman, Foster, Bliss and Chief Larson who would be acting in the capacity as an advisor. Martin moved to approve the sub-committee as recommended. The motion was seconded by Beckman and passed with Directors Lattin and Foster voting "Aye". Hooper abstained as he has previously mentioned applying for the Chief position.
