# RECORD OF THE PROCEEDINGS OF THE REGULAR BOARD MEETING OF THE PAGOSA FIRE PROTECTION DISTRICT BOARD OF DIRECTORS

## November 14, 2023

The regular meeting of the Pagosa Fire Protection District Board of Directors was held on Tuesday, November 14, 2023. This meeting was held at 165 N. Pagosa Blvd., Pagosa Springs, Colorado. These meetings are open to the public.

## **Call to Order**

Chairman Lattin called the meeting to order at 5:30 p.m.

## Regular Meeting Minutes – October 10, 2023

The minutes from the October 10, 2023 regular meeting were approved with a motion by Beckman, seconded by Hooper and passed unanimously.

## **Old Business**

# A. Consideration and Recommendation from the Apparatus Committee Regarding Tender Purchase

Chief Bertram advised Captain Johnson and Driver Operator Josh Butcher were present representing the Apparatus Committee with their recommendations regarding the potential tender purchase. Captain Johnson distributed documentation with their recommendation from Mile-Hi Fire Apparatus, Inc. Chief Bertram advised a new contract needs to be addressed as the bid has expired. Beckman moved to table this item awaiting a new bid and clarification on specifications. Hooper seconded the motion and it passed unanimously.

#### **New Business**

A. Consideration of Changing the Meeting day and time in order to have legal counsel present

Lattin moved to change the 2024 meeting dates to the first Tuesday of the month with the time remaining at 5:30 p.m. Beckman seconded the motion and it carried unanimously.

# B. Consideration of Engagement Letter with Mayberry for 2023 Audit Services

Chief Bertram presented an Engagement Letter for Board approval for 2023 Audit Services with Mayberry. Chief Bertram expressed his familiarity with Mayberry and reiterated their cost for services was approximately \$22,000 less than the District's current provider. Foster moved to approve signing the letter engaging audit services with Mayberry. Martin seconded the motion and it carried unanimously.

C. Consideration of a Letter to the Archuleta County Treasurer Authorizing Changes to Direct Deposit Account

Manager Bliss presented a Letter to the Archuleta County Treasurer for approval authorizing future disbursements to be directly deposited into the newly established ColoTrust account. Beckman moved to approve the letter as presented. Martin seconded the motion and it carried unanimously.
